Rules and Regulations

- 1. All entries must be one float or one vehicle or one marching group. These are called units. Any applicant that has more than one unit must pay the additional unit charge per unit (i.e., A marching group with an accompanying vehicle would be considered two units and would pay one entry fee PLUS one Additional Unit fee. Please see the fee schedule below.)
- 2. <u>All floats and vehicles MUST be decorated AND lighted (No Exceptions)</u>
- 3. NO ONE can be dressed as Santa Claus or have a Santa mannequin on your float or vehicle. Santa will be the last entry of the parade.
- 4. Entries must be submitted with full payment and description of the entry, organization, and details of the construction. **Incomplete applications will be returned.** Checks should be made payable to the Liberty County Chamber of Commerce (LCCOC) and mailed to 208 East Court Street, Hinesville, GA 31313. The fees are listed below.
- 5. Parade participants **WILL NOT** throw candy, beads, or any other objects into the crowds. You may walk the parade route and <u>hand out</u> items. If you are caught throwing items, you will not be allowed to participate in the Christmas parade anymore.
- 6. Absolutely NO SMOKING (regardless of age) on staging grounds.
- 7. Participants must adhere to the rules and directions of the Chamber Staff, Parade Committee and law enforcement officials.
- 8. There will be a mandatory meeting on Tuesday, November 28th at 5:45pm at the Hinesville Police Department for the point of contact for each entry. If at least ONE representative of each entry does not attend admittance can be denied on Parade Day without a refund & a \$50 penalty fee will be assessed if the entry is allowed in. No exceptions.
